Subject - Renewal of IBA Group Health Insurance Policy for the Retirees for the year 2025-26 – Undertaking with regard to GST

This is for the attention of all the retirees/ compulsorily retired employees and spouses of such deceased ex-employees who have opted for IBA Medical Insurance Policy for retirees for the period 01.11.2025 to 31.10.2026.

Pursuant to the interim order dated 31.10.2025 passed by the Hon'ble High Court of Kerala, Ernakulam in Writ Petitions 38552 of 2025, 38670/2025, 36757/2025 together with similar batch petitions seeking stay on collection of GST on premium towards renewal of IBA Medical Insurance policy for Retirees, all the retirees/ compulsorily retired employees/ resignees who are drawing pension/ spouses of such deceased ex-employees, who have opted for IBA Medical Insurance Policy for retirees for the period 01.11.2025 to 31.10.2026 are required to submit an undertaking letter as per Annexure to this Internal Communication so as to comply with the directions of the Hon'ble High Court.
