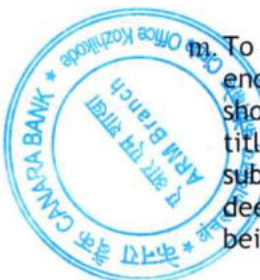

- e.
