In terms of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015, the Stock Exchanges are hereby informed that the Reserve Bank of India (RBI) has imposed a monetary penalty of Rs. 4,35,550 (Rupees Four Lakh Thirty Five Thousand Five Hundred Fifty Only) on the Bank for Shortage of Notes, Mutilated Notes in Currency Chest Balance and other deficiencies observed/found during the inspection conducted from 29<sup>th</sup> to 31<sup>st</sup> October, 2025.
