ACCOUNTS OF FOREIGN NATIONALS IN INDIA.



A. Foreign National visiting India on Tourist VISA.

Foreign Nationals visiting India on tourist VISA can open only an NRO account.

Frequently Asked Questions

1. Can foreign tourists open a bank account in India during their short visit?

Yes. Foreign tourists during their short visit to India can open a Non-Resident Ordinary Rupee (NRO) account (Current / Savings). Such account can be opened up to a maximum period of 6 months.

2. What are the documents required for opening such accounts?

The foreign national is required to furnish copies of the following documents to open the bank account:

- Abroad passport containing identity and address of home country.
- Immigration Endorsement
- Valid VISA
- Current proof of address
- For continuation of account beyond 6 months RBI permission is required (FRRO Registration)

3. What credits can be made to such accounts?

Funds remitted from outside India through banking channel or those obtained by sale of foreign exchange brought by the tourists to India can be credited to the account.

4. Can the account be used for making local payments?

Yes. Tourists can freely make local payments through the NRO account.

5. Can foreign tourists repatriate the balance held in their NRO account at the time of departure from India?

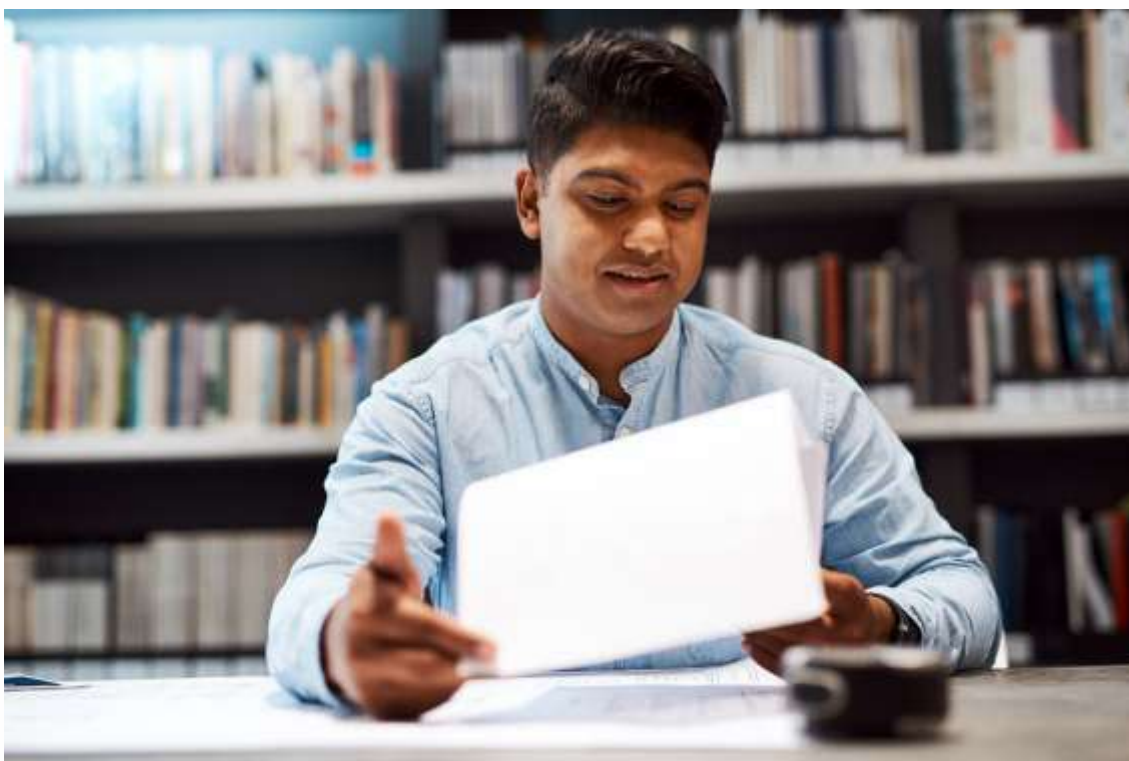
Banks can convert the balance in the account for payment to the account holder at the time of departure from India into foreign currency, provided the account has been maintained for a period not exceeding six months and the account has not been credited with any local funds, other than interest accrued thereon.

B. Foreign National student studying in India.

Foreign nationals coming to India for studies can open only an NRO account.

KYC Documents:

- Abroad passport containing identity and address of home country
- Immigration Endorsement
- Valid VISA
- Admission letter from educational institution
- Current proof of address within one month of account opening
- For continuation of the account beyond 6 months RBI permission is required (FRRO Registration)





C. Foreign Nationals coming to India for Employment or Business purpose

Foreign nationals (excluding OCI/PIO card holders) can open resident savings or current account with a bank in India provided they furnish requisite KYC documents.

D. Opening of accounts by individuals/entities of Pakistan nationality/ownership and Bangladesh nationality/ownership.

- Branches/Offices may open only one Non-Resident (NRO) account for a citizen of Bangladesh or Pakistan, belonging to minority communities in those countries, namely Hindus, Sikhs, Buddhists, Jains, Parsis and Christians, residing in India and who has been granted a Long-Term Visa (LTV) by the Central Government.
- The account will be converted to a resident account once such a person becomes a citizen of India within the meaning of the Citizenship Act, 1955.
- This account can also be opened if such person has applied for LTV which is under consideration of the Central Government, in which case, the account will be opened for a period of six months and may be renewed at six monthly intervals subject to the condition that the individual holds a valid visa and valid residential permit issued by Foreigner Registration Office (FRO)/Foreigner Regional Registration Office (FRRO) concerned.
- The opening of such NRO accounts will be subject to reporting of the details of the accounts opened to the Ministry of Home Affairs (MHA) on a quarterly basis.
- Opening of NRE accounts in the names of Pakistani nationals of Indian origin /Pakistani Entities/Bangladesh Entities requires prior approval of Reserve Bank of India.
