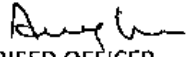

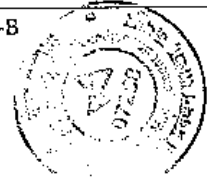

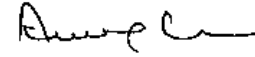
Special Instruction/Caution
