Earnest Money deposit	The bidder shall have to deposit earnest money in the form of DD/BG of Rs. 50,000.00 (Rupees Fifty Thousand only ) for CCTV/Alarm System and Rs. 20,000.00 (Rupees Twenty Thousand only ) for Fire Extinguishers in favour of Canara Bank, Circle Office Patna. It should be valid for one year from last date of submission of bid. The period of EMD can be extended further as per Bank's requirements with reference of RFP processing. Format of EMD/Bank Guarantee may be obtained from Circle Office, Patna.
