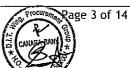

13. Amended Penalties/Liquidated Damages:

- 13.1. Penalties/Liquidated damages for delay in Supply, Installation, Configuration, Implementation and Maintenance of Servers and Other related items would be as under:
 - 13.1.1. Non-compliance of the Supply/delivery as per clause 11.1 will result in the Bank imposing penalty of 0.50% on delay in delivery per week or part thereof, on the invoice value of Servers & Other Items (exclusive of Taxes) (Amended Annexure-10 Bill of material Sl. No. 1, 2 & 3 of Table A) location/office address wise.
 - 13.1.2. Non-Compliance of the Installation, configuration, implementation as per clause 11.2 will result in the Bank imposing penalty of 0.50% on delay in installation per week or part thereof, on the invoice value of Servers & Other Items (exclusive of Taxes) (Amended Annexure-10 Bill of material Sl. No. 1, 2 & 3 of Table A) location/office address wise.
 - 13.1.3. However, the total Penalty/LD to be recovered under above clause 13.1.1 and 13.1.2 shall be restricted to 10% of the total value of Amended Annexure-10 Bill of material Table A only.

13.2. Penalties/Liquidated damages for not maintaining uptime:

13.2.1. If the bidder fails to maintain the guaranteed Uptime during Warranty and AMC/ATS period (if contracted), the penalty for Uptime will be deducted as under:

- 13.2.2. The Maximum Penalty levied under the above clause shall not be more than 10% of the Order value during warranty period. The maximum penalty levied shall not be more than the 50% of AMC/ATS amount payable for one year after warranty period.
- 13.2.3. If monthly uptime is less than 96.50%, the Bank shall levy penalty as above and shall have full right to terminate the contract under this RFP or AMC/ATS, if contracted. The right of termination shall be in addition to the penalty. The above penalty shall be deducted from any payments due to the bidder (including AMC/ATS payments).
- 13.3. Penalties/Liquidated Damages for non-performance: If the specifications of the RFP are not met by the bidder during various tests, the bidder shall rectify the same at



bidders cost to comply with the specifications immediately to ensure the committed uptime, failing which the Bank reserves its right to invoke the Bank Guarantee.

- **13.4.** The selected bidder shall perform its obligations under the agreement entered into with the Bank, in a professional manner.
- 13.5. If any act or failure by the bidder under the agreement results in failure or inoperability of systems and if the Bank has to take corrective actions, to ensure functionality of its property, the Bank reserves the right to impose penalty, which may be equal to the cost it incurs or the loss it suffers for such failures.
- 13.6. If the Bidder fails to complete the due performance of the contract in accordance with the specification and conditions of the offer document, the Bank reserves the right either to cancel the order or to recover a suitable amount as deemed reasonable as Penalty / Liquidated Damage for non-performance.
- 13.7. Any financial loss to the Bank on account of fraud taking place due to selected bidder, its employee or their services provider's negligence shall be recoverable from the Successful Bidder along with damages if any with regard to the Bank's reputation and goodwill.
- **13.8.** Bank may impose penalty to the extent of damage to its any equipment, if the damage was due to the actions directly attributable to the staff of the selected bidder.
- 13.9. The liquidated damages/penalties shall be deducted / recovered by the Bank from any money due or becoming due to the bidder under this purchase contract or may be recovered by invoking of Bank Guarantees or otherwise from bidder or from any other amount payable to the bidder in respect of other Purchase Orders issued under this contract, levying liquidated damages without prejudice to the Bank's right to levy any other penalty where provided for under the contract.
- **13.10.** All the above LDs are independent of each other and are applicable separately and concurrently.
- 13.11.LD is not applicable for the reasons attributable to the Bank and Force Majeure. However, it is the responsibility/onus of the selected bidder to prove that the delay is attributed to the Bank and Force Majeure. The selected bidder shall submit the proof authenticated by the selected bidder and bank's official that the delay is attributed to the Bank and Force Majeure at the time of initial payment
