## Roles of OEM resource

- 1. OEM resource should be available between 10 AM to 6 PM on all working days.
- 2. In case of exigencies, even during off business hours / bank holidays/ drills, the resource should be required to be present onsite.
- 3. The resource should have minimum BE / B Tech / MCA or Equivalent Degree in Computer Science / Information Technology / Electronics & Communications / Equivalent Trades with minimum 3 years of hands on experience in managing the proposed solution including all components covered under this bid.
- 4. The resource should have obtained Certification of the Proposed Solution.
- 5. If the performance of resource is not satisfactory, selected bidder has to replace the resource within 15 days from the date of communication from the Bank.
- 6. In the event of resignation of the resource, the selected bidder will give prior written notice to the Bank and arrange for resource replacement and knowledge transfer to new resource before exit of the existing one.
- 7. The billing of onsite support will be commenced after successful project implementation sign-off/acceptance. However, selected bidder has to ensure that onsite resource should be part of the project implementation team.
- 8. The selected bidder has to submit following KYC documents for onsite resource:
  - 8.1. Resume latest (Candidate Photograph should be part of Resume only) and Print should be in color only.
  - 8.2. Address Proof (Local and Permanent) Duly attested photocopy by candidate and OEM's HR.
  - 8.3. Aadhaar Card Duly attested photocopy by candidate and OEM's HR.
  - 8.4. Relieving Certificate of Previous employer Duly attested photocopy by candidate and OEM's HR.
  - 8.5. Passport Duly attested photocopy by candidate and OEM's HR.
  - 8.6. Background Police Verification report Duly attested photocopy by candidate and OEM's HR.
- 9. The resource will be first level of escalation for any issues that are identified in the working of solution.
- 10. The resource will be responsible for the escalating the issue with the OEM, arranging call, collecting logs and coordinating to resolve the issue.
- 11. The resource will be responsible for performing quarterly policy configuration checks on the solution and appliance and provide report to the Bank along with recommendations if any.



- 12. The OEM resource shall be guide the on-site support team for attending antivirus issues in coordination with different authorized vendors of the Bank.
- 13. The resource shall advice the Bank on the latest threat scenarios or for version upgrades whenever available. The OEM resource shall coordinate with the Bidder resources in implementing controls for the risk advised by regulators/Govt. of India.
- 14. The resource should send daily report on the status of service requests raised with OEM, any other critical issues identified/reported etc.
