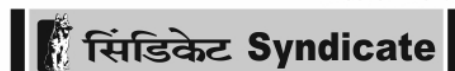

### NOTICE FOR EMPANELMENT OF CONSULTANTS AND CONTRACTORS

The Premises & Estate Section of Canara Bank, Circle Office- Patna is managing Bank's branches/offices/other business and non business units spanning across various locations in state of Bihar. The branches/ offices are further controlled down the line by 5 Regional Offices namely PATNA-I, PATNA-II, GAYA, MUZAFFARPUR & PURNEA.

The intention of this notice of empanelment is to maintain a unanimous panel of consultants & contractors for various traits, the details of which are as under:

#### 1. Consultants/Auditors:

- Architects
- Electrical Engineering Consultant
- Electrical Engineering Auditors (BEE Certified)

#### 2. Contractors:

- Civil Engineering Works
- Interior Furnishing Works
- Electrical Works
- Air Conditioning works
- Glow Sign / Signage Board works

**All consultants, auditors & contractors in the existing panel should also apply afresh for empanelment.**

The eligible and interested architects & contractors and suppliers may download "Document for empanelment" from the Bank's website [www.canarabank.com](http://www.canarabank.com).

The duly filled in application addressed to the Assistant General Manager, Circle Office, PATNA along with all the necessary supporting documents & a non-refundable application fee of Rs.1,000/- (Rupees One Thousand Only) in the form

of Demand Draft (D.D.) favouring “Canara Bank, Circle Office” payable at PATNA shall be submitted to the mentioned correspondence address before the stipulated date & time. The applications without the application fee would be rejected. There is no exemption for submission of Demand Draft.

The duly completed document in the prescribed format with all supporting documents shall be sealed in a cover and super scribed as “**APPLICATION FOR EMPANELMENT OF (CATEGORY NAME) - 2023**” and shall be submitted to the above mentioned office of CANARA BANK on or before 02.05.2023 up to 02:00 pm.

Please note that applicant opting for multiple categories through single application will not be considered for empanelment. There shall be different applications for different categories.

Applications without application format or incomplete application format will be rejected.

The Bank reserves the right to accept or reject any or all the applications without assigning any reasons thereof and their decision of selection will be final.

**GENERAL RULES AND INSTRUCTIONS**

1. Generally, the routine works of the Bank are awarded/ procurements are made on calling competitive tenders/quotations from the empanelled contractors. In case of emergency works or works of small magnitude, the Bank may opt to award the work/ procure supply on nomination basis from any of the empanelled contractors, depending on the geographical suitability, exigencies of the work. Bank also has the right to adopt open tendering process for any particular work, depending on the nature & magnitude of the work.
2. The details of the applicants and their experience shall be furnished in the prescribed “Application Format” only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexure but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.
3. **All consultants & contractors in the existing panel should also apply afresh for empanelment. The consultants & contractors, who intend to apply for more than one category, have to apply for each category using separate application forms and submit in independent covers super scribing in the envelope the category of work applied for.**
4. No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
5. **Documentary proof with respect to the prequalification criteria shall be furnished along with the application form. In this regard, copies of the work orders / completion certificates / or such other documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be liable for rejection and no correspondence will be entertained in this regard.**
6. The authorised person of the firm/ company shall sign in all the pages of the application with seal of the company/ firm.
7. The empanelment will be made for a specific category depending on the credentials submitted. However, the applicant empanelled in higher category shall be eligible for works in the lower category.
8. The evaluation will be based on the experience, empanelment with other Banks, PSUs, Govt. institutions, their financial capabilities etc. Based on the details furnished and eligibility criteria, the applicants will be empanelled. Decision of the Bank regarding selection/ rejection for empanelment will be final and binding and no further correspondence will be entertained. Only the empanelled contractors will be informed through post.
9. If, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.

10. Applications received after the due date and time is liable for rejections.
11. The present empanelment is mainly for works for value up to the limits mentioned in respective categories. In case of any high value works, Bank may undertake the works by project specific pre-qualification exercise.
12. The applicants having their registered offices within the state of Bihar will be preferred. The applicants must have their branches/offices / establishments in state of Bihar.
13. The applicant must ensure compliance with the labour laws and guidelines. The selected vendors/ consultants should have a well defined Business Continuity Plan in place for continuation of the entrusted works in case of an emergency / disaster. A certificate in this regard shall be submitted to the Bank on regular intervals.
14. Canara Bank reserves its right to reject any/ or all the applications without assigning any reasons whatsoever.
15. Empanelment with the Bank is in no way whatsoever a guarantee that the empanelled consultant/ contractor would be awarded all or any works desired to be executed by the Bank after their empanelment. Empanelment of consultant/ contractor does not entitle/ guarantee them for participation in tender/ calling for quotations or tender or any other similar exercise undertaken for award of work. Nor does the empanelment with the Bank entail that the Bank, in any way whatsoever, is bound to involve the panel consultant / contractor in the process of tendering, calling for quotations or any other similar exercise undertaken before award of work.
16. Although the empanelled consultants/ auditors/ contractors are expected to extend their services across 37 districts under the jurisdiction of Patna Circle Office, the applicants can consent to extend their services to specific Regional Office(s) (R.O.) of our circle depending upon the districts coming under them where they find it suitable to render services keeping in mind their location(s), manpower, material mobilization capacity etc.

**Note:**

1. If other things are found equal, the professionally qualified applicants and the applicants who have undertaken the works for PSU Banks will be preferred.
2. All class & types of applicants must be Income Tax Assessee. The applicants, otherwise eligible but not Income tax assesses, will not be considered for empanelment.
3. If contractors, consultants are otherwise eligible but not registered for GST, will not be considered for empanelment.

## **SCOPE, ELIGIBILITY CRITERIA AND RELATED DETAILS**

### **I. CONSULTANTS / AUDITORS**

The professionals experienced in planning, designing, preparation of tender documents, supervision of works wherever required, assisting the Bank in techno-commercial aspect with exposure to Government & Central Vigilance Guidelines will be preferred.

#### **Eligibility:**

The consultant should have the following minimum eligibility criteria:

- i) The applicant should have provided consultancy services in Government departments / public sector undertaking/ central autonomous bodies/ state autonomous bodies/ financial institutions for similar works:  
For one project costing 80% of the class limit **or**  
For two projects costing 50% of the class limit **or**  
For three projects costing 40% of the class limit  
during last five years as on 31.12.2022
- ii) The applicant should be an assessee of Income Tax and must possess GST Registration. Should submit copy of the Income Tax PAN, GST certificate with valid registration number.
- iii) The applicant shall have the average annual financial turnover of at least 30% the value of the class limit in the respective category during last 3 years ending with 31.12.2022. Applicant should submit copies of Audited/ Provisional Balance Sheets and tax return receipts.

#### **A. ARCHITECTS :**

**Scope:** Architects' services include planning, designing, supervising & execution of Civil Engineering works, interior furnishing works, electrical works, other infrastructure creation works for the offices/ residences of the Bank, providing the specifications of the materials, assisting the Bank in finalizing the contractor and supervision of the interior works. The panel architects services will also be availed for planning, designing and execution of redeveloping of Banks own buildings involving the approval for the same from the local Authorities.

**Eligibility:**

1. Graduate/ Post graduate degree in Architecture with minimum 5 years of experience in the respective field as on 31.12.2022.
2. The Architect must have registered with the council of Architecture/ Members of the Indian Institute of Architecture and should have experience in planning, designing and supervising Civil Engineering, Interior works for the Banks, Financial Institutions and other reputed organisation/s.
3. Architectural firms having engineering department with personnel having required qualification and meeting the other eligibility criteria can also apply.

**B. ELECTRICAL CONSULTANTS /:**

**Scope:** The services of Electrical consultants will be used for planning and execution of the electrical works for the Bank offices including procurement of electrical equipments like Generators, Transformers and other allied items, electrical auditing, energy audit and coordinating/ liasoning with Govt. Electricity Board & such other authorities.

Bank is looking for consultants who have specialized in the field of electrical engineering with the knowledge on HT sub-station, internal electrical system for a computerized office environment, specialized electro-mechanical works like DG sets, lifts, Building Management System, air-conditioning etc.

**Eligibility:**

1. Graduate in Electrical Engineering with minimum 5 years of experience in the respective field as on 31.12.2022.
2. Should have experience in planning, designing and supervising of electrical works for computerized environment including experience in LT/HT works, generator and motors, UPS, lifts etc. for the Banks, Financial Institutions and other reputed organisation/s.
3. Applicants having Energy Auditor's / Energy Manager's licence issued by the relevant Govt. Authorities will be preferred.

**C. ELECTRICAL ENGINEERING AUDITORS (BEE CERTIFIED) :**

**Scope:** The services of Electrical Engineering Auditors will be used by the Bank for electrical audit & related works.

**Eligibility:**

1. Graduate in Electrical engineering with minimum 5 years of experience in the electrical auditing field as on 31.12.2022.

2. The Auditor must be Bureau of Energy Efficiency (BEE) Certified and should have experience in conducting electrical audit for the Banks, Financial Institutions and other reputed organisation/s.
3. Electrical firms having engineering department with personnel having required qualification and meeting the other eligibility criteria can also apply.

### **GENERAL**

Generally, the routine interior works, civil, electrical and air-conditioning works as detailed above are being carried out. The services of the consultants will be availed as and when it is required depending on the magnitude and specialization required for the project.

It is proposed to avail services of consultants from the approved panel for the interior works costing up to Rs. 50.00 lacs, Electrical works upto Rs. 50.00 lacs. However, the Bank has right to avail the services of any consultant from outside the panel depending on the circumstances.

Note: In all the above categories of consultants, if other things being equal, the consultants having the experience in the contract administration for government, PSUs and Public Sector Banks and Financial Institutions will be preferred.



## II. CONTRACTORS

Empanelment of Contractors is sought for the following categories of works under various cost limits. The contractors empanelled under lower cost limit will not be eligible to quote for the works costing more than the limit. However, the contractors empanelled under higher class can participate even for works in lower cost limits.

### ELIGIBILITY:

#### For Class- A, B & C

The applicant should have the following minimum eligibility criteria:

1. The applicant should have undertaken works in Government departments/ public sector undertaking/ central autonomous bodies/ state autonomous bodies/ financial institutions and other reputed private firms during last 5 years as on 31.12.2022:  
One work/project costing 80% of the class limit **or**  
Two works/projects costing 50% of the class limit **or**  
Three works/projects costing 40% of the class limit
2. The applicant should be an assessee of Income Tax and must possess GST Registration. Should submit copy of the Income Tax PAN, GST certificate with valid registration number. Solvency Certificate (not older than 6 months from the date of release of empanelment) of same value of class limit applied for is to be mandatorily enclosed.
3. The applicant shall have the average annual financial turnover of at least two times the value of the class limit in the respective category during last 3 years ending as on 31.12.2022.

#### For Class- D

The applicant should have the following minimum eligibility criteria:

1. The applicant should have undertaken works in Government departments/ public sector undertaking/ central autonomous bodies/ state autonomous bodies/ financial institutions and other reputed private firms during last 2 years as on 31.12.2022

2. The applicant should be an assessee of Income Tax. Should submit copy of the Income Tax PAN with valid registration number, GST registration certificate. In case the firm/company etc. is not having G.S.T number, contractor should apply for G.S.T number and submit a copy for the acknowledgement form along with a declaration for having applied for G.S.T registration. Shortlisted vendor must submit GST Number before commencement of work. Solvency Certificate (not older than 6 months from the date of release of empanelment) of same value of class limit applied for is to be mandatorily enclosed.

### **GENERAL**

- 1) Based on the assessment of details furnished like works undertaken, technical & financial capabilities, selection will be made.
- 2) The Suppliers should be original manufacturers/ suppliers of the items having wide dealer and service network in the geographical Jurisdiction of PATNA Circle Office. They should be established in this field for minimum of 5 years.
- 3) The supplier shall provide details of the personnel, equipment and manufacturing facilities.

### **SCOPE OF WORKS:**

1. **Civil Engineering Works:** The scope of work broadly is to undertake new constructions, redevelopment of existing properties, periodical repairs & renovations, flooring, painting, plumbing & sanitary, demolition works, structural steel fabrication, wood work (doors and windows only), waterproofing works of terrace, lift well, toilets etc. and other allied works for branches/offices of the Bank. The contractors should have well-established office with adequate engineering staff.
2. **Interior Furnishing Works:** The scope of work broadly is to undertake original works, alterations and renovations involving erection of partitions work both wood & aluminium, counters, panelling, false ceiling, vinyl flooring, vitrified tiles flooring, granite flooring, storage units, furniture, Aluminium / wood doors and windows works, paintings, fabricated workstations etc. and other allied works for furnishing of our branches/offices/other units.
3. **Electrical Works:** The scope of work broadly is to undertake LT as well HT electrical works, providing panel board for LT applications, providing protective switchgear, internal and external electrification along with outlet points, associated cabling, copper plate/chemical/GI earthing, point wiring for appliances/components like air-conditioners, UPS etc., providing electrical equipment like luminaries, fans, light fixtures etc. of reputed makes, cabling for voice communication along with preparation of outlet points, electrical wiring for a computerized office environment along with preparation of outlet points, liaisoning with Electricity Dept. for requirements like obtaining additional power, fault management, metering and billing & any other requirements like breakdown repair and other allied works.

The electrical works also involves domestic electrical works which may be required at Bank's own buildings which include attending to any LT works, liaisoning with Electricity authorities according to the requirements, attending to repairs of electrical appliances like fans, switch boards, re-wiring and cabling works.

In addition to above, Electrical contractors must enclose necessary permits / license from Government Electricity Department or equivalent.

#### 4. Air Conditioning Works:

Applications are invited for Supply and installation of various types of Acs - Window, Split, Cassette, Ductable, Packaged AC, VRF AC systems, & Comprehensive Annual Maintenance Contract of Air-conditioners (Split, Cassette, Ductable, Packaged, VRF, Centralized Chiller Plant).

- i. The vendor should be an authorized dealer of any one of the preferred brand of ACs - Voltas, Bluestar, LG, Carrier, Toshiba, Daikin, Hitachi, Godrej.
- ii. The vendor should have an office or branch in any of the towns at Patna, Muzaffarpur, Gaya, Purnea located in the State of Bihar
- iii. The applicant should be a well established and reputed establishment (for a minimum period of 5 years as on 31.12.2022)
- iv. The vendor should have a valid GST and PAN registration.
- v. Applicants should have experience in having successfully completed "Similar work" (in/under single order) value as prescribed in table 'A' above for Government /Semi-Government/PSUs/Banks/ Financial Institutions / Reputed MNCs/IT companies during the last 5 years ending on 31.12.2022. The information must be supported with the copies of Work Order, Satisfactory Completion Certificate, etc.,.
- vi. The applicant should submit the valid authorized dealer certificate / letter issued by Original Equipment Manufacturers (OEM) of the air-conditioners specifying the validity of the certificate.
- vii. Applicants should have minimum average annual turnover prescribed in above table during last 3 years ending on 31st March of last financial year i.e.31.03.2022.
- viii. The applicant should not have been disqualified/ debarred/ terminated on account of poor or unsatisfactory performance/ blacklisted from any Government, Semi-government, PSU, Banks or any other organizations including any of the Offices/Branch of State Bank of India during last 5 years as on the date of publication of this notice. The undertaking in this tender notice to be submitted on the Letter Head of the Firm duly signed by the vendor/ Authorized Signatory. The application of disqualified/ debarred/ blacklisted/ terminated agency/ contractor/ vendor on account of poor or unsatisfactory performance shall be summarily rejected.
- ix. Initially the empanelment is valid for a period of three years, subject to renewal of Validity every year after submission of valid dealership certificate and authorization letter from the OEM or incase if the expiry of dealership certificate arrives early, its renewal copy shall be submitted to us for active of their Empanelment. Bank may review / update the panel at regular intervals and may

Include or Exclude (de-list) or Update any firm from the Empanelment without assigning any reasons thereof.

- x. The Contractors submitting authorization for a particular Brand are eligible to quote only for those Brands, weather it is a single or Multi Brand. Multibrand dealers may submit the proof of authorization from the respective OEM and valid dealership certificate for that various brands then the Vendor will be eligible to quote only for that Brands mentioned. For multibrand dealers also the renewal of their empanelment for every year (with in total period of 3 years) is applicable as mentioned.
- xi. The Bank may choose to carry out physical inspection of works mentioned by the applicants in their application forms, in addition to calling for confidential reports from the respective employer/client/department to ascertain their capability and quality of works. The applicant shall agree and authorize the Bank to obtain the confidential report from the clients, to obtain credit opinion from the Bankers and to verify the work executed by the contractors.
- xii. The firm/ contractor should have the minimum annual turnover as mentioned and shall be profit making during last three financial years ending 31.03.2022. Vendor should submit a certificate from the Chartered Accountant confirming turnover and profit / loss details of the last 3 years ending 31.03.2022.

- 5. Glow Sign / Signage Board vendors-** The applicant shall be either original manufacturers of Flex, Vinyl, Biodegradable and eco friendly Cotton coated fabric used in Signage's or their Authorised dealers or converters. The Bidder to submit proof in this regard.- Certificate of Original Manufacturer Equipment / OEM's certificate for Authorised Distributor of (LG or 3M or Avery or Arlon) or Converters.

The applicant should have at least minimum of 5 years experience as on 31.12.2022 in the activity of providing sign Boards to PSU Banks/ Pvt Banks. Order copies older than 5 years from the date of this advertisement is to be attached. Purchase order copies and satisfactory completion certificates clearly indicating the cost & nature of work executed, date of commencement & completion issued by the Clients/ Consultants may be enclosed.
