The document submitted without the prescribed fee will be summarily

rejected.

The duly completed document in the prescribed format with all supporting documents shall be sealed in a cover and super scribed as 'Application for EMPANELMENT of (<u>Category Name</u>)' and shall be submitted to the above mentioned office of CANARA BANK on or before 21.07.2021 up to 04.00 <u>PM.</u> Separate application forms are to be submitted for different categories of contractors & suppliers.

The Bank reserves the right to accept or reject any or all the applications without assigning any reasons thereof.

GENERAL RULES AND INSTRUCTIONS TO THE INTENDING APPLICANTS

- 1.0. The empanelment of Consultants, contractors and suppliers are proposed for the Architects, Electrical, Interior works and other allied works of routine nature in the Branches and offices of the Bank coming under the Circle Office, Guwahati. Generally, the routine works of the Bank are awarded/procurements are made on calling competitive tenders/quotations from the empanelled contractors/suppliers. However, the Bank has the right to award the work/procure supply from any of the empanelled agencies, depending on the exigencies of the work and also opt for open tendering process for any particular work, depending on the nature & magnitude of the work.
- **2.0.** This document consists of the following:
 - 2.1. Notice inviting applications for empanelment of contractors and suppliers
 - 2.2. General rules and instructions to the intending applicants
 - 2.3. Scope, cost wise sub-classification and eligibility criteria for each category.
 - 2.4. Application format for empanelment
- **3.0.** The complete document as detailed above, complete in all respects, should be submitted by the intending applicants within the stipulated date and as per the instructions given in the Notice inviting applications. The details of the applicants and their experience shall be furnished in the prescribed "Application Format" only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexure but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.

The checklist given along with the application should be duly filled up and should be submitted along with applications and supporting documents. The applications without documents of checklist are liable for rejection.

- **4.0.** The Contractors/suppliers, who intend to apply for more than one type of vendors, have to apply for each type using separate application forms and others.
- **5.0.** No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
- **6.0.** Documentary proof with respect to the details furnished in the application form regarding eligibility criteria shall be furnished along with the application form. In this regard, copies of the work order and completion certificate and/or such documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be summarily rejected and no correspondence will be entertained in this regard.
- **7.0.** If the application is made by a partnership firm, a certified copy of the partnership deed, current address of the firm and the full names and current addresses of all the partners of the firm shall also accompany the application.
- **8.0.** If the application is made by a limited company, it shall be signed by a duly authorized person holding the power of attorney for signing the application in which case certified copies of the power of attorney and the certification of incorporation, Memorandum of Articles of Association shall accompany the application.
- **9.0.** The empanelment shall be made for a specific category as per the application received supported by documentary proofs. For different category the applicant has to apply using separate application form.

- **10.0.** The evaluation will be based on the experience, reputation, empanelment with other **Banks**, **PSUs**, **Govt institutions**, manpower & logistical support of the applicant, their financial capabilities, quality consciousness, etc and if found necessary may also include inspecting the works undertaken by them for which, necessary co-ordination shall be made by them. Based on the details furnished and inspection of works, eligibility criteria, the applicants will be empanelled. Decision of the Bank regarding selection / rejection for empanelment will be final and binding and no further correspondence will be entertained. The empanelled contractors will only be informed by post.
- **11.0.** If, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
- **12.0.** Applications received after the due date and time is liable for rejections.
- **13.0.** The consultants/contractors/suppliers having their office in the geographical jurisdiction of the Circle office as mentioned above will only be considered. If Corporate / Registered office is outside of north-east (except Sikkim) then at-least local office with full support shall be situated in North-East (except Sikkim). The empanelment shall be valid up to 3 YEARS under normal circumstances provided there is no disciplinary/ de-empanelment clause raised against them.
- **14.0.** Canara Bank reserves its right to reject any / or all the applications without assigning any reasons whatsoever.

SCOPE, COST WISE SUB-CLASSIFICATION AND ELIGIBILITY CRITERIA FOR CONTRACTORS / ARCHITECTS.

Empanelment of Contractors is sought for the following categories of works under various cost limits. The contractors empanelled under lower cost limit will not be eligible to quote for the works costing more than the limit. However, the contractors empanelled under higher class can participate even for works in lower cost limits.

ELIGIBILITY CRITERIA SUPPLIERS: FOR GLOW SIGN BORAD/SECURITY EQUIPMENTS (CCTV/ALARM etc.) / COURIER SERVICES/FIRE EXTINGUISHERS/PEST CONTROL SERVICE:

Based on the assessment of details furnished like works undertaken, technical & financial capabilities, selection will be made. From such panel, competitive offers/tenders will be called for specific works.

SCOPE OF THE WORKS:

ARCHITECTS:

• Graduate/Post Graduate diploma in Architecture/Civil Engineering with minimum 5 years of experience in the respective field as on 31.03.2021. The Architects with specialization in Interior designing of Bank's & other PSU will be preferred.

• The Architect must have registered with the council of Architecture and have experience in designing and supervising interior works for the Banks/ Financial Institutions/software companies with lighting details, electrical, data-cabling and Air-conditioning layouts.

Note:: The Architect who meet the other requirements but not exactly meeting any of the above criteria may also be considered for empanelment but they will be allowed to quote for the works up to Rs.10.00 lakhs only.

INTERIOR FURNISHING WORK:

The scope of work of Contractors for Interior works mainly include original works, alterations and renovations of the branch premises involving erection of partitions work both wood & aluminium, counters, paneling, false ceiling, cavity flooring, storage units, furniture and fabricated workstations and other allied furnishing works.

ELECTRICAL CONTRACTORS:

The scope of work for Electrical Contractors is to undertake HT as well LT works, panel board for LT applications, will be mainly used for internal and external electrification, associated cabling, copper plate earthing, wiring for air-conditioners, UPS, liasoning with state electricity board for obtention of additional power, breakdown repair, interior wiring for computerized office environment and other allied works like data cabling. The electrical works also involves domestic electrical works attending to LT side, liasoning with state electricity board in case of meter burnouts etc. attending to repairs of electrical appliances like fans, geysers, pumps & motors, switch boards, re-wiring and cabling works. Exposure to repairs of other appliances like fridge, mixers, washing machines etc. will be added advantage. Electrical contractors shall have necessary permits / license from concerned office and familiar with IE rules & regulations and guidelines.

SUPPLY AND FIXING OF GLOW SIGN BOARD

The scope of work includes supply, Installation and maintenance of Glow Sign Board, ACP, Non Lit Boards, Name Boards and various other Bank Signage as required from time to time. They should have qualified artwork designing team. The vendor should have sufficient knowledge in Sign board area, quality product and having good skills workers in this field.

SUPPLY AND INSTALLATION OF SECURITY SYSTEM (FIRE ALARM, BURGLAR ALARM, AUTO DIALER, CCTV SURVEILLANCE SYSTEMS ETC)

scope of work for Contractors of the Fire detection and alarm System, Burglar Alarm System, Auto Dialer System and CCTV etc (as applicable) mainly involves all original works, alterations and modifications involving supply, installation, testing and commissioning for branches / offices of a Bank / Government Departments / Public Sector Undertaking / Central Autonomous Bodies / State Autonomous Bodies / Financial Institutions or other reputed firms. The suppliers should have minimum of 3 years experience in supplying various type of Fire detection and alarm System / Burglar Alarm System / Auto Dialer System / CCTV system / equipments with different Capacity to large Offices. Also the suppliers should have sufficient staff and satisfactory experience in maintenance of all type of such Security equipment systems as applicable. They should have qualified dealer of security equipments as per ISI/BIS standard with dedicated team to provide service in entire NE states. The vendor should have sufficient knowledge having good skills workers in this field.

COURIER SERVICES:

Courier Service Provider should have office in the geographical Jurisdiction of Guwahati City and good service network in Urban, Semi urban and Rural areas of north eastern state. They should have all India presence. Office in other important cities of NE states will be preferred. Proof of address with copy of lease agreement for proof of ownership should be attached in support of this. The Courier agency should have provided satisfactory service in the respective region to any of the Scheduled Banks / Financial institutions / Government Departments having all India network etc. Order copies OR Satisfactory certificate from the clients with number years of service should be attached. The Courier Agency having the facility of Web tracking of the Courier / Consignments will be preferred.

SUPPLY/REFILLING OF FIRE EXTINGUISHER

Scope of work for Contractors of the Fire Extinguishers mainly supply, installation, testing and commissioning & refilling for branches / offices of a Bank / Government Departments / Public Sector Undertaking / Central Autonomous Bodies / State Autonomous Bodies / Financial Institutions or other reputed firms. The suppliers should have experience in supplying/refilling various type of Fire Extinguishers with different Capacity to large Offices. Also the suppliers should have sufficient staff and satisfactory experience in maintenance of all type of such Security equipment systems as applicable. If Banks requires imported Security items then the vendor should have the direct dealership of the products which he needs to be supplied.

PEST CONTROL SERVICES

The service provider should have minimum 3 years experience in Pest Control service for all types of insects, rodents and snakes and should have completed servicing worth not less than Rs. 500000.00 and should have at least one single similar work costing not less Rs.100000.00 during the last one year prior to 31.03.2021.

The service provider should get the PAN number from Income Tax Authorities and GST number from Goods and Services Tax Department within 6 months from the date of empanelment failing which, they will not be allowed to quote for any further works.
