GENERAL RULES AND INSTRUCTIONS TO THE INTENDING APPLICANTS:

- 1. The empanelment of vendors is proposed for the (CCTV, Fire alarm system including auto dialer, Security alarm system, Fire Extinguishers) at Branches / Offices / Chests of the Bank coming under the Patna Circle office. Generally, the routine works of the Bank are awarded/procurements are made as per Standardized rates. However, the Bank has the right to award the work/procure supply from any of the empanelled agencies, depending on the exigencies of the work.
- 2. This document consists of the following:
 - a) Notice inviting applications for empanelment of Security Items vendor/supplier.
 - b) General rules and instructions to the intending applicants
 - c) Scope, eligibility criteria & general terms & conditions for each category.
 - d) Tender Offer
 - e) Application format for empanelment
 - f) Check list of documents furnished.
 - g) Technical Specifications
 - h) Price Bid
- 3. The document as detailed above in (a) to (e), complete in all respects, should be submitted by the intending applicants within the stipulated date and as per the instructions given in the Notice inviting applications. The details of the applicants and their experience shall be furnished in the prescribed "Application Format" only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexures but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.
- 4. No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
- 5. Documentary proof with respect to the details furnished in the application form regarding eligibility criteria shall be furnished along with the application form. In this regard, copies of the work order and completion certificate and/or such documents shall be submitted. <u>Incomplete applications or applications without proper proofs for establishing their credentials will be summarily rejected and no correspondence will be entertained in this regard.</u>
- 6. If the application is made by a partnership firm, a certified copy of the partnership deed, current address of the firm and the full names and current addresses of all the partners of the firm shall also accompany the application.

- 7. If the application is made by a limited company, it shall be signed by a duly authorized person holding the power of attorney for signing the application in which case certified copies of the power of attorney and the certification of incorporation, Memorandum of Articles of Association shall accompany the application.
- 8. The empanelment shall be made for a specific product category; however one vendor can be empanelled for more than one product category if they are eligible.
- 9. The evaluation will be based on the experience of the contractors / suppliers and their financial capabilities and may also include inspecting the works furnished by them for which, necessary co-ordination shall be made by them. Based on the details furnished and inspection of works, eligibility criteria, the consultants/ contractors/ suppliers will be empanelled. Decision of the Bank regarding selection / rejection for empanelment will be final and binding and no further correspondence will be entertained. The empanelled contractors will only be informed by post / email.
- 10. If, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
- 11. Application received after the due date and time is liable for rejection.
- 12. The contractors/suppliers having their registered / local office in the geographical jurisdiction of the Circle office (preferably in Bihar) will only be considered. The empanelment shall be valid for a minimum period of Three years.
- 13. Canara Bank reserves its right to reject any / or all the applications without assigning any reasons whatsoever.
- 14. The vendor assessment will be final post physical clearance of demonstration of equipment at circle office.
- 15. The vendor must furnished training of their staff from the Concern OEM.
- 16. Review from other Public Sector Bank/ organization will be taken for final selection of vendor.
- 17. Existing empanelled agency need to apply again. If we are not getting proper response from such empanelled vendor then Bank have right reject their empanelment request.



SCOPE, AND ELIGIBILITY CRITERIA FOR CONTRACTORS

A. SCOPE OF WORK:

New Installation and Annual Maintenance Contract for new as well as existing Security equipments (Fire Alarm system, Burglar alarm System, CCTV system, Fire Fighting Equipments viz Fire extinguishers) and buy back of any system of "Fire Alarm System with Auto Dialer, Burglar alarm System, CCTV System, Fire Fighting Equipments installed at Branches / Offices / Chests of Canara Bank, Under Circle office Patna on as and when required basis. The Vendor will maintain all Security equipment (irrespective of Make and Model) installed earlier in the branches/ATMs & officesat the quoted rates.

B. **ELIGIBILITY CRITERIA:**

For this purpose Vendors/Firms/Suppliers shall submit proof of documents along with the Tender, if Vendors/Firms/Suppliers are not submitting documentary proof and / or not conforming to any of these parameters will not qualify for empanelment or short listing:

- Technical bid along with supporting documents should be in sealed envelope duly superscripted "TECHNICAL BID FOR SUPPLY, INSTALLATION AND MAINTENANCE OF SECURITY & FIRE SAFETY SYSTEMS" (Whichever is applicable).
- Financial Bid rates of AMC and spare parts items of CCTV, Fire Alarm and Security Alarm systems and Fire Extinguishers

Note: The tender documents should be submitted duly signed and stamped at each page by authorized signatory. FAX/Telegram/Telex/email or any form of electronic communication will not be acceptable.

Late Bids:-Any bid received after the deadline as prescribed by the Bank will be rejected and/or returned unopened to the Bidder, if bidder desireso.

C. GENERAL CRITERIA, TERMS & CONDITIONS - Empanelment

- a. Empanelment shall be done for category of Class A i.e. upto 10.00 Lakhs values for CCTV, Burglar/Fire Alarm System and Class B i.e. upto 5.00 Lakhs for Fire Extinguishers.
- b. The Vendors/Firms/Suppliers should have sales turnover of 40 Lakhs or above for CCTV, Burglar alarm System & Fire Alarm System and Detection system and 20 lakhs for Fire Fighting Equipments average in the last 3 years (copy of duly audited Balance sheet to be attached for last three years).

- c. The firm should have satisfactorily completed works, as stated below during the last 3 years prior to 31.12.2022.
 - i) Three similar works each costing not less than 4 Lakhs

OR

ii) Two similar works costing not less than 5 Lakhs

OR

iii) One similar works costing not less than 8 Lakhs

Similar work shall mean Supply, Installation, Testing, Commissioning and Maintenance of Standalone Digital Video Recorder (SDVR) or NVR based Closed Circuit Television Systems (CCTV) and Fire and Security Alarm System, Installation and refilling of Fire Extinguishers for any reputed organization.

- d. The Vendors/Firms/Suppliers should have earned profit consecutively during the last three years (copy of duly audited Balance sheet to be attached for last three years).
- e. Firms should be registered companies/their authorized dealers/authorized suppliers reputed in the concerned field with not less than five years dealing in the products offered. (Attested copies or original Work orders will be accepted as proof and attested copies of certificate of corporation to be submitted)
- f. Product quality and Robustness: All Products for which BIS standards exist should conform to those standards.
 - g. After sales service network within "Patna Circle office jurisdiction". The Firm should have at least one of its own office and service centre functioning in Bihar. (Firms should submit attested copies of original rent receipt or any proof to prove that it has own office and service centre functioning in Bihar to apply).
 - h. The Vendors/Firms/Suppliers should have an office/service center in Bihar: the Vendors/Firms/Suppliers are interested to apply with sufficient network to support for attending any request for rectification in a short span of time. The firm should have sufficient network of service Engineers in the Bihar state under the jurisdiction of Patna Circle Office.
 - i. The Vendors/Firms/Suppliers applying for CCTV/Fire Alarm/BAS Systems should have installed/ looking after the Annual Maintenance for CCTV/Fire Alarm/BAS Systems of at least one Public Sector Banks/ Public Sector Undertakings (other than Canara Bank) for at least last 3years (Vendor should provide reference site details in the specified annexure andthey will qualify only, if the Bank get positive feedback from the quoted references.)
- *j*. The Vendors/Firms/Suppliers with Test report by the Circle Electronic Test Development centers or BIS certification is must. (Attested copies or original Proof, if any has to be submitted).
- k. After the demonstration, if the board requests to provide another demo in another/same premises to ensure the quality of the product, the vendor should provide it without any additional charges.
- l. Firms should have Income Tax PAN, GSTN and the latest Clearance Certificate. (Attested copies of PAN card and latest Income tax return to be submitted)

- m. Firms should have Registration under Shops & Establishments Act. (Attested copy of certificate to be submitted)
- n. Firms should have one office with telephone and Email facility and office should be manned during the office hours. Email will be considered as valid means to report compliant and vendor is bound to attend the complaint within 48 hrs latest.
- o. Firms shall not be owned or controlled by any director or officer/employee of the Bank or their relatives having the same meaning as assigned under Section 6 of the Companies Act 1956. (A certificate denying the ownership of Agency/Firm/Manufacturer/ Dealer by any director or officer/ employee of the Bank or their relatives having the same meaning as assigned under Section 6 ofthe Companies Act 1956 issued by the CEO or Director of the Firm to be submitted along with the Tender).
- p. Firms should submit an undertaking (on their letter head) that they have not been "Black Listed" by any of the Govt. Authority or PSUs/PSBs duly signed by authorized signatory with company seal.
- q. Firms should have registration number for payment of GST (Attested copy of proof to be submitted with company seal)
- r. Tenders which are not in sealed covers will not be accepted.



D. GENERAL TERMS & CONDITIONS - Empanelment

- a) The date of award of AMC shall be for duration of 01 years from the award of AMC, renewable subject to the performance. The period of one year would be divided into four quarters and security system is to be checked thoroughly each quarter to ensure its fitness at buildings / properties.
- b) In case of new installation, Bank shall right to entrust empanelled vendor as per requirements with approved rates.
- c) The gap between each AMC visit should be not less than 60 days.
- d) No separate labour charges/ service charges shall be admissible for troubleshooting / defect rectification.
- e) Break down calls are to be attended immediately within 24 hours at free of cost.
- f) Proper Identity cards (with photograph) are to be issued to the service technician/ engineers to have access to the location / sites and the said personnel should report to the concerned Security Officer / bank official while attending to the repair or service.
- g) No payment of any nature is to be obtained from the staff at the location. Payment of AMC shall be done from controlling office on production of service reports& invoice only.
- h) All the Branches are to be covered under AMC and are to be visited quarterly. Bills will be cleared only when the complete list of Branches allocated to the vendor is submitted duly signed/endorsed by the Branch along with the copy of service report.
- All new units and parts replaced should carry a warranty of one year during which no service maintenance charges should be collected. After rectification of the system it should carry a warranty of 12 months during which no service/ maintenance charges should be collected.
- j) During the visit the staffs are to be briefed/ demonstrated the usages of the system.
- k) A spare component is to be provided for the period during which the defective component is taken out or in case the repair of the main unit takes a longer time to be completed.
- Any abnormally low rates quoted with regard to the prevailing market rates may entail disqualification from participating in the tender process and may be summarily rejected by the bank.
- m) All the old items/replaced spares/ parts, etc are to be taken back by the vender under the Buy Back clause and a marginal value of the same will be paid to the Bank by the vendor.
- n) The bank reserve the right to terminate the service contract with one month notice without assigning any reason whatsoever

PROCEDURE FOR AWARD OF AMC:

- o) The Tender would be a Two Bid tender system comprising of Technical and Financial bid. The vendor would be shortlisted based on the technical evaluation done as per the eligibility criteria given above. Suitable marks would be awarded to shortlisted vendors against each criteria and a sum total of the marks would be taken to form a merit list for finalizing the empanelment and awarding AMC contract as per **Technical Bid rating chart** as shown below. The bidders who score minimum 60 shall be considered for further empanelment. The Financial bid would be opened only for the vendor finalized by the technical evaluation committee.
- p) The appropriate L1 rate for AMC and each spare / accessory and full system for new installation, viz. CCTV / Fire Alarm System / Fire Extinguisher shall be initially fixed as the benchmark / standard for the rate of the particular spare / accessory/set that shall be eventually followed by the bank.
- q) The L1, L2, L3,L4 and L5 vendors in respect of their offered AMC rates (for each Security / Fire Safety equipment) shall then be asked for their willingness to render AMC services equipment-wise at the corresponding standardized rate of that equipment.
- r) The number of vendors between L1, L2, L3,L4 and L5 agreeable to the rate list of equipment would then be awarded AMC for the locations on a proportionate basis. Bank shall right to split the work as per Bank's requirement.

TECHNICAL BID RATING CHART

As per process of empanelment deals with the submission of documents and fulfilling the required eligibilities criterion; the list of empanelled vendors will be made on a score of maximum point in 9 different parameters. The applicant, who scores minimum 60 points out of 100, will be considered successful, as per following evaluation /scoring system.

In case where quantifiable information is NOT available /provided, for calculation of points, following proportionate scale will be used and accordingly the points will be awarded:

Excellent/Best -> Very Good -> Good -> Satisfactory -> Bad/Worst (Highest Point) (Lowest Point)

The scores will be awarded on the basis of information provided, inquiries made over phone/email or similar means feedback received from other counterparts. This score may also be used for distribution of work in case of multiple firms are eligible by fulfilling criterion.



E. VALIDITY PERIOD

- a. The empanelled Vendors/Firms/Suppliers will remain in the empanelled list of the Bank for Patna Circle for three years from the date of empanelment or till the completion of next empanelment period at the Bank's own discretion (whichever is earlier). Empanelment of the Vendors/Firms/Suppliers will be reviewed after 1 year subject to service & performance standards and may be extended if required.
- b. The Annual rate contract will be valid for (01) one year and will be reviewed subject to service & performance standards.
- c. Empanelment will be valid only, if all eligibility criteria mentioned in the advertisement are fulfilled during the entire empanelment period.
- d. If the service provided by vendor is found to be unsatisfactory or if at any point of time during the empanelment it is found that the information provided by vendor is false or if vendor do not participate in any subsequent RFP or tendering process three times consecutively, the Bank reserves the right to remove the vendor from the empanelment list without giving any notice. Bank's decision in this regard willbe final.

Bank reserves the right to reject an offer under any of the following circumstances:

- 1. Bid security (EMD) is not submitted.
- 2. Incomplete Offer and/or all documents not attached.
- 3. Offer is not in conformity with the terms and conditions stipulated in this document. Specifications stipulated in RFP are not met with. However, deviations resulting in higher / superior configuration will be accepted.
- 4. If Technical Offer contain any price information.
- 5. Commercial Offer format differs from actual Commercial Offer format.
- 6. Or violates any terms and conditions in the RFP document.
- 7. Or If found that the information provided in the offer is false.
