GENERAL RULES AND INSTRUCTIONS TO THE INTENDING APPLICANTS

- 1. Generally, the routine works of the Bank are awarded/procurements are made on calling competitive tenders/quotations from the empanelled contractors/suppliers and in case of emergency works/ works of small magnitude, the Bank may opt to award the work/procure supply from any of the empanelled agencies, depending on the exigencies of the work on nomination basis and also has the right for open tendering process for any particular work, depending on the nature & magnitude of the work.
- 2. The details of the applicants and their experience shall be furnished in the prescribed "Application Format" only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexures but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.
- 3. The Consultants/Contractors/Suppliers, who intend to apply for more than one category, have to apply for each category using separate application forms along with separate Demand Draft and submit in independent covers super scribing in the envelope the category of work applied for.
- No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
- Documentary proof for the work orders and completion certificates or such other documents shall be submitted along with the application. Incomplete applications or applications without proper proof for establishing their credentials will be liable for rejection and no correspondence will be entertained in this regard.
- The authorised person of the firm/ company shall sign in all the pages of the application with seal of the company/firm.
- The empanelment will be made for a specific category depending on the credentials submitted. However, the applicant empanelled in higher category shall be eligible for works in the lower category.
- 8. The evaluation will be based on the experience, reputation, empanelment with other Banks, PSUs, Govt institutions, manpower & logistical support of the applicant, their financial capabilities, quality consciousness, etc. and if found necessary may also include inspecting the works undertaken by them for which, necessary co-ordination shall be made by them. Based on the details furnished and inspection of works, eligibility criteria, the applicants will be empanelled. Decision of the Bank regarding selection / rejection for empanelment will be final and binding and no further correspondence will be entertained. The empanelled contractors will only be informed by post.
- If, information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
- Applications received after the due date and time is liable for rejection.
- The Applicants having their office / Sales & Service centre in the geographical jurisdiction of Madurai Circle (As Mentioned Above) and Neighbouring districts of

Kerala sharing borders with Tamilnadu (subject to approval of Competent Authority) will only be preferred.

- The empanelment shall be valid for a period of three years from the date of intimation letter to the shortlisted contractors.
- 13. The present empanelment is mainly for works for value upto the limits mentioned in respective categories. In case of any high value works, Bank may undertake the works by project specific pre-qualification exercise.
- 14. The applicant should be a profit making firm for the last 3 years as on 31.03.2022.
- Canara Bank reserves its right to reject any / or all the applications without assigning any reasons whatsoever.
- 16. Firms should submit an undertaking (On their Letter Head) that they have not been "Blacklisted" by any of the Govt Authority / PSUs / PSBs duly signed by authorised signatory with company seal.
- 17. The Firm should open a current account with Canara bank on receiving enrolment letter after completion of the process. No payment for the work will be disbursed to any other bank accounts.
- 18. Empanelment provides an opportunity to firms to participate in the tender process invited from time to time for various routine works. Empanelment does not provide a guarantee for getting any work assigned. The Applicant should be in touch with the Premises and Estate section after the empanelment process.

19. As the process of Empanelment deals with the submission of documents and fulfilling the required eligibility criterion; the list of Empanelled Vendors will be made based on a score of 100 maximum points in 10 different parameters. The applicant, who scores minimum 40 points out of 100, will be considered successful, as

In cases where quantifiable information is NOT available / provided, for calculation of points, following proportionate scale will be used and accordingly the points will be awarded:

Excellent/ Best → Very Good → Good → Satisfactory → Bad → Very Bad/Worst (Highest Point) (Lowest Point)

The scores will be awarded on the basis of information provided, inquiries made by phone or email or similar means, feedback received from other counterparts and agencies, visits made and similar methods as approved by our authorities. This score may also be used for distribution of work in case of multiple firms are eligible by fulfilling the criterion.

20. PERFORMANCE EVALUATION OF EMPANELLED CONTRACTORS/ SUPPLIERS/ CONSULTANTS/ SERVICE PROVIDERS:

The performance of empanelled contractors, suppliers, consultants, service providers etc will be monitored regularly to assess their suitability/ functioning. Their rating of evaluation shall be based on their adherence to delivery schedules, consistency in quality and competitive costs, integrity and service rendered during warranty and Annual Maintenance contract period.

21. REMOVAL OF CONTRACTORS/ SUPPLIERS/ CONSULTANTS/ SERVICE PROVIDERS FROM PANEL:

Removal of empanelled contractors, suppliers, consultants, service providers etc from the list shall be considered on the following grounds:

- The performance is rated below par during the performance evaluation process.
- The firm fails or neglects to respond to three consecutive invitations to tender within the range of products for which it is registered.
- · The firm fails to execute a contract/ order.
- The firm found not have the required technical man power/ equipment/machines.
- · The firm is declared bankrupt or insolvent or willful defaulter.
- The firm fails to furnish the income tax clearance certificate or any other document when called for.

22. BAN AND BLACK LISTING:-

When the misconduct of a firm or its continued poor performance, it is justified to impose ban on business relation with the firm or it's Blacklisting. This action will be taken after due consideration of all factors and circumstances of the case. Ban for a specified period of time may also be imposed by The Bank.

CRITERIA FOR EXEMPTION OF APPLICATION FEE/TURNOVER FOR CONTRACTORS/SUPPLIERS

Purchase Preference to Micro and Small Enterprises (MSEs) and Start-ups and Purchase Preference linked with Local Content (PP-LC) shall be applicable subject to full compliance of other terms and conditions of the RFP and Contract. Following are the conditions applicable as per the Government of India Guidelines on Purchase Preference.

1. Micro & Small Enterprises [MSEs]:

Procurement through MSEs (Micro & Small Enterprises) will be done as per the Policy guidelines issued by the Ministry of Micro, Small & Medium Enterprises vide Gazette notification no. D.L.-33004/99 dated 23.03.2012 and as amended from time to time. Following are the conditions applicable as per the Government of India Guidelines. Vide Notification No. S.O. 2119(E) dated 26.06.2020 Ministry of Micro, Small & Medium Enterprises (MSME) issued the revised guidelines regarding criteria for classification of enterprises as Micro, Small & Medium Enterprises and their mandatory registration in Udyam Portal. All existing enterprises registered under EM-Part-II or UAM (Udhyog Adhar memorandum) required registering again on the Udyam Registration portal.

- All MSME registered vendors are required to submit the Udyam Registration Certificate as a proof of registration in order to avail the benefits of a MSME firm.
- 1.2. MSEs participating in tenders, quoting price within price band of L1+15% shall also be allowed to supply a portion of requirement by bringing down their price to L1 in a situation where L1 price is from someone other than MSE & such MSE shall be allowed to supply at least 20% of total tendered value. In case there are more than one MSEs within such price band and agree to bring down their price to L1, the 20% quantity is to be distributed proportionately among these Bidders.
- MSEs are exempted from paying Application fee/cost & EMD, subject to furnishing of valid certificate for claiming Exemption.

2. Startup:

- 2.1. Applicable for Indian Bidders only as defined in gazette notification no. D.L33004/99 dated 11.04.2018 of Ministry of Commerce and Industry and as amended from time to time.
- 2.2. As mentioned in Section-II of O.M. No.F.20/2/2014-PPD(Pt.) dated 20.09.2016 of Procurement Policy Division, Department of Expenditure, Ministry of Finance on Prior turnover and prior experience, relaxations may be applicable for all Startups [whether Micro & Small Enterprises (MSEs) or otherwise] subject to meeting of the quality and technical specifications specified in tender document.
- 2.3. Further, the Startups are also exempted from submission of Tender Fee and FMDs.
- 2.4. For availing the relaxations, bidder is required to submit requisite certificate towards Start up enterprise registration issued by Department of Industrial Policy and Promotion, Ministry of Commerce and the certificate should be certified by the Chartered Accountant (not being an employee or a Director or not having any interest in the bidder's company/firm) and notary public with legible stamp.
- 2.5. Bidder has to submit as self-declaration accepting that if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the RFP, they will be suspended for the period of three years from being eligible to submit Bids for contracts with Canara Bank.

SCOPE, COST WISE SUB-CLASSIFICATION AND ELIGIBILITY CRITERIA FOR ARCHITECTS/ CONSULTANTS

It is proposed to classify each category of consultants depending on their past performance, technical and financial capabilities. The consultants empanelled under lower class/category will not be eligible to participate for the works of higher class/category.

Note:

 In the categories of consultants, other things being equal, the consultants having the experience in the contract administration for government, PSUs and Public Sector banks and Financial Institutions will be preferred.

2. The firms /companies meeting the eligibility criteria and having the qualified personnel as detailed above can also apply.

CONSULTANTS

The professionals experienced in planning, designing, preparation of tender documents, supervision of works wherever required, assisting the Bank in techno-commercial aspect with exposure to Government & Central Vigilance Guidelines will be preferred.

GENERAL ELIGIBILITY:

The consultant should have the following minimum eligibility criteria:

i. The consultant should have provided consultancy services for similar works during the last Five years prior to 31.03.2022for:

One project costing 80% of the class limit or

Two projects costing 50% of the class limit or Three projects costing 40% of the class limit

fi. The consultant should be an assesse of Income Tax, Service tax, etc.

ARCHITECTS:

<u>Scope:</u> Architects' services include planning, designing, supervising & execution of Civil Engineering works, interior furnishing works, electrical and air conditioning works, strong room certification and other infrastructure creation works for the offices/residences of the Bank, providing specifications of materials, assisting the Bank in finalizing the contractor and supervision of interior works if sought by Bank. The panel architect's services will also be availed for planning, designing and execution of redeveloping of Banks own buildings involving the approval for the same from the local Authorities.

Eligibility:

- Graduate/ Post graduate degree in Architecture with minimum 5 years of experience in the respective field as on 31.03.2022.
- 2. The Architect must have registered with the council of Architecture/Members of the Indian Institute of Architecture and should have experience in planning, designing and supervising Civil Engineering, Interior, Electrical and air conditioning works for the Banks, Financial Institutions and for software companies.
- Architectural firms having engineering department with personnel having required qualification and meeting the other eligibility criteria can also apply.

CIVIL AND STRUCTURAL ENGINEERING CONSULTANT:

<u>Scope:</u> Civil Engineering consultants' services shall be used for planning, designing, estimation, tendering and supervision of execution of Buildings construction & repairs/ renovations/ maintenance and other Civil works of Bank's own buildings.

The scope of Structural Engineering Consultants include assessment of repairs, renovation (in some cases involving structural evaluation) and recommending correct rectification works, periodical evaluation of buildings for structural conditions, if necessary by undertaking necessary structural studies and submitting technical assessment reports suggesting remedial measures, providing structural stability reports for Bank Buildings, providing structural fitness certificate to preparation of tender papers and assisting the Bank in undertaking repair works with or without their site supervision.

Eligibility:

 Graduate in Civil Engineering with post graduation in structural Engineering having minimum 5 years of experience in planning, designing of multi storied buildings and supervision of buildings, sanitary and plumbing services and other allied works as on

- 31.03.2022. The consultant with post graduation in structural Engineering with experience in repairs and rehabilitation of the structures will be preferred.
- Should have experience in planning, designing and supervision of Civil Engineering Constructions repair/ renovation works including water proofing works of buildings. Experience in planning and estimation of multi storied buildings shall be an added advantage
- Copy of license issued by competent authority of Government.
- Copy of certificate of corporate member of civil engineering division of the Institution of Engineers, India.

ELECTRICAL AND AIRCONDITIONING CONSULTANTS:

<u>Scope:</u> The services of consultants will be used for planning and execution of the electrical and AC works for the Bank offices including procurement of electrical equipment like Generators, UPS, Transformers and other allied items, electrical auditing, energy audit and coordinating/ liasoning with State Electricity board in Tamilnadu.

The electrical system of the Bank owned buildings are with HT substation and some are supported by DG sets. Bank may propose to upgrade such electrical HT system. In such cases Bank may avail the services of consultants who have specialized in the field of electrical engineering with the knowledge on HT sub-station, internal electrical system for a computerized office environment, specialized electro-mechanical works like DG sets, lifts, Building Management System, air-conditioning, solar Projects etc.

Eligibility:

- Graduate in Electrical Engineering with minimum 5 years of experience in the respective field as on 31.03.2022.
- Shall possess Tamilnadu State electrical supervisor license (Grade A or B)
- Should have experience in planning, designing and supervising of electrical works for computerized environment including experience in LT/HT works, generator and motors, UPS, lifts.

GENERAL CONDITIONS APPLICABLE FOR ALL CONSULTANTS:

Generally, the routine interior works, Civil, electrical and air-conditioning works as detailed above are being carried out by the Bank's Engineers. The services of the consultants will be availed as and when it is required depending on the magnitude and specialization required for the project.

It is proposed to avail services of consultants from the approved panel for the interior works costing up to Rs.100.00 lacs, Civil works costing up to Rs.100.00 lacs, Electrical works upto 50 Lacs & Air-conditioning works upto Rs.30.00 lacs. However, the Bank has right to avail the services of any consultant from outside the panel depending on the circumstances.

Note: In all the above categories of consultants, if other things being equal, the consultants having the experience in the contract administration for Government, PSUs and Public Sector Banks and Financial Institutions will be preferred.

SCOPE, COST WISE SUB-CLASSIFICATION AND ELIGIBILITY CRITERIA FOR CONTRACTORS, SUPPLIERS CUM SERVICES AND ONLY SERVICES

Empanelment of Contractors/suppliers is sought for the following categories of works under various cost limits. The contractors/suppliers empanelled under lower cost limit will not be eligible to quote for the works costing more than the limit. However, the contractors/suppliers empanelled under higher class can participate even for works/ supply in lower cost limits.

General Conditions:

Eligibility: The applicant should have the following minimum eligibility criteria:

i. The applicant should have undertaken works in Government Departments/ Public Sector Undertaking/ Central Autonomous Bodies/ State Autonomous Bodies/ Financial Institutions during last 5 years prior to 31.03.2022:

II. CONTRACTORS:

2. INTERIOR FURNISHING WORKS:

Eligibility: The applicant should have the following minimum eligibility criteria:

Except for Class D, the contractors for other classes should have well established work shop for preparing the furnishing/ furniture items. Class A, B contractors shall have full-fledged work shop for preparing the furnishing/ furniture items.

Scope: To undertake fresh works, alterations and renovations involving erection of partitions work both wood & aluminium, counters, panelling, false ceiling, cavity flooring, storage units, furniture and fabricated workstations and other allied works for furnishing of our bank branches.

3. ELECTRICAL WORKS:

Except for Class D, the contractors for other classes should have well established office in the respective centre with adequate engineering staff.

Scope: To undertake HT as well as LT works, panel board for LT applications, will be mainly used for internal and external electrification associated cabling, copper plate earthing, wiring for air-conditioners, UPS, liasoning with State Electricity Boards or their allied bodies for obtention of additional power, breakdown repair, interior wiring for computerized office environment and other allied works.

The electrical works also involve domestic electrical works attending to LT side, State Electricity Boards or their allied bodies in case of meter burn outs etc. attending to repairs of electrical appliances like fans, geysers, pumps & motors, switch boards, re-

good service network so as to cater to the needs of all our branches/ATMs/Admin Units
etc. They should have established service centers at Tamilnadu. (Dealership
certificate from the OEM is mandatory and needs to be enclosed along with the
application form, also applicant needs to mention in the application format
separately for which brand the applicant has applied).

2. FIRE EXTINGUISHERS & FIREFIGHTING SYSTEM SUPPLIER:

Eligibility: The suppliers should have minimum of 5 years' experience in supplying various type of Fire fighting equipment with different Capacity to large Offices Public Sector/ Private Sector Banks, PSUs, Govt. organisations as mentioned in the main eligibility criteria. Also the suppliers should have experience in maintenance of all type of Fire extinguishers. If Banks requires imported FE the vendor should have the direct dealership of the products he needs to be supplied.

Scope: Supply and installation of fire extinguishers and fire fighting systems in offices/branches under the jurisdiction of Madurai Circle Office.

CCTV SYSTEM SUPPLIER:

Eligibility: The suppliers should have minimum of 5 years' experience in supplying various type of CCTV System with different Capacity to large Offices Public Sector/ Private Sector Banks, PSUs, Govt. organisations as mentioned in the main eligibility criteria. Also the suppliers should have experience in maintenance of all type of CTV systems. If Banks requires imported system, the vendor should have the direct dealership of the products he needs to be supplied.

Scope: Supply and installation of CCTV systems in offices/branches under the jurisdiction of Madurai Circle Office.

4. FIRE AND BURGLARY ALARM SYSTEM SUPPLIER:

Eligibility: The suppliers should have minimum of 5 years' experience in supplying various type of fire and burglary alarm system to Offices of Public Sector/ Private Sector Banks, PSUs, Govt. organisations as mentioned in the main eligibility criteria. Also the suppliers should have experience in maintenance of all type of F&B alarm systems.

Scope: Supply and installation of fire and burglary alarm systems in offices/branches under the jurisdiction of Madurai Circle Office.

GLOW SIGN BOARD SUPPLIER:

Eligibility: The suppliers should have minimum 5 years' experience in supply and installation of signage for various offices, Public Sector/ Private Sector Banks, PSUs, Govt. organisations as mentioned in the main eligibility criteria. Applicant should be authorized converter of any of the preferred make. Applicant shall submit authorized converter certificate along with application.

Similar works means all original works, alterations and modifications involving supply, installations, testing and commissioning of glow sign board related works for branches/ offices of a bank.

The preferred make of flex and Vinyl shall be 3M, LG, and Avery Dennison.

MODULAR FURNISHING & READY SUPPLY ITEMS:

Eligibility: The Companies/ Agencies/ authorized franchisees, having well established manufacturing & marketing facilities in the area of chairs, sofas, modular work stations, low height & full height partitions with MS / Aluminium frame works, post forming & edge banding facilities etc., in modular furnishing works and who have executed such works are eligible to apply. Considering the products profiles, manufacturing facilities, business turn over, the eligible agencies will be

empanelled. The applicants are requested to furnish the full details of the company's product profile, client list details of major projects executed with documentary proof.

Scope: Supply of chairs, sofa and installation of modular furniture as per design given by Bank or their consultant in offices/branches under the jurisdiction of Madurai Circle Office

All class of contractors must be income Tax Assessee. The contractors, otherwise eligible but not income tax assesses, will not be considered for empanelment.

All contractors, consultants should have registered for GST. If otherwise eligible but not registered for GST will not be considered for empanelment.

SMF AND TUBULAR BATTERY SUPPLIERS:

Eligibility: The suppliers should have minimum of 5 years' experience in supplying various type of Batteries viz. tubular, SMF of various capacities for branch, office, ATMs to Offices of Public Sector/ Private Sector Banks, PSUs, Govt. organisations as mentioned in the main eligibility criteria. Also the suppliers should have experience in maintenance of all type of batteries. The supplier should be capable of supplying battery to required site within 24 hrs in times of emergency. However reasonable time for delivery will be stipulated in individual orders.

The supplier should be an authorized dealer/ distributor of reputed branch batteries like Exide, Amaron, Luminous etc. as desired by bank.

PLUMBING - PETTY WORKS

Eligibility: The contractor who intends to apply should have two years' experience of successfully completing plumbing repair works involving internal and external works associated with plumbing lines, waste lines, drainage & storage sump, pumps etc. and any other related works, preferably for branches/ residential quarters/ offices of PSBs/PSUs/Govt Offices etc. prior to 31.03.2022. Eligibility:-The contractor who intends to apply should possess technical qualification background in the field of Refrigeration engineering either in atleast IT or Diploma. The applicant should have minimum of two years experience in the field of servicing, installation and maintenance of Split, cassette and ductable ACs Experience in offices of PSBs/PSUs/Govt Offices etc. prior to 31.03.2022 will be given more priority.

Scope: undertaking low side work for installation of ACs supplied by bank, dismantling, refixing of ACs from branches, ATMs including necessary materials.

Providing AMC/CAMC service for existing as well as new ACs in Offices, Branches and ATMs for uninterrupted functioning. Breakdown calls to be attended on top priority.

ANNUAL MAINTENANCE WORKS FOR CCTV, FIRE AND BURGLAR SYSTEM.

Eligibility:-The contractor who intends to apply should possess technical qualification background in the field of CCTV, fire and burglar system either in at least IT or Diploma atleast a certificate of vocational training. The applicant should have minimum of two years experience in the field of servicing, installation and maintenance of CCTV, Fire and burglary alarm systems. Experience in offices of

PSBs/PSUs/Govt Offices etc. prior to 31.03.2022 will be given more priority.

Scope: undertaking installation work of CCTV, Fireand Burglary systems supplied by bank, dismantling, refixing of systems from branches, ATMs including necessary materials.

Providing AMC/CAMC service for existing as well as new CCTV, F&B systems in Offices, Branches and ATMs for uninterrupted functioning. Breakdown calls to be attended on top priority.

5. ANNUAL MAINTENANCE WORKS FOR UPS AND INVERTER.

Eligibility:-The contractor who intends to apply should possess technical qualification background in the field of electrical/ electronics engineering either in atleast IT or Diploma. The applicant should have minimum of two years experience in the field of servicing, installation and maintenance of inverters, UPS of various capacities ranging from 1KW to 50KW. Experience in offices of PSBs/PSUs/Govt Offices etc. prior to 31.03.2022 will be given more priority.

Scope: undertaking low side work for installation of machines/ batteries supplied by bank, dismantling, refixing of units from branches, ATMs including necessary materials. Providing AMC/CAMC service for existing as well as new UPS and inverter of various capacities in Offices, Branches and ATMs for uninterrupted functioning. Breakdown calls to be attended on top priority.

6. COURIER AND POSTAL SERVICES:

Eligibility:-The contractor who intends to apply should have minimum 5 years experience of successful operation in postal services with registered trade mark having established service centres in the districts mentioned in page 3 of this document. Only those having services to minimum 90% of these districts will be considered during evaluation. The applicant should produce experience of successful/ satisfactory association with offices of PSBs/PSUs/Govt Offices etc. prior to 31.03.2022 for a minimum period of 2 years.

Scope: Confidential and Ontime delivery of tapals with due diligence and handled with care. Daily collection of tapals/ parcels from branches/ offices all over the command area of Madurai circle. (Details as in page 3 of the document)

SCRAP VENDORS FOR DESTRUCTION OF OLD RECORDS

Eligibility:-It is essential that the agencies have office in Tamilnadu and should have necessary knowledge to segregate old records, slip bindles as per bank's policy and to make systematic disposal as per directions of RBI. Cost of the work will be as per rates standardization from time to time at the discretion of bank. Applicants should have necessary equipment like shredders and adequate man power for the work. The applicant should produce experience of successful/satisfactory association with offices of PSBs/PSUs/Govt Offices etc. prior to 31.03.2022 for a minimum period of 2 years.
